### **EXAMPLE OF COOPERATION AMONG INTEGRA INTERNATIONAL FIRMS**

An example of where assistance between members can take place in a transnational insolvency is where a case involves insolvency proceedings or a business rescue situation in one country, with creditors and/or assets located in at least one additional country. In the more complex cases, this may involve fellow members in other jurisdictions being required to assist in advising subsidiaries, safeguarding and recovering assets, overseeing and advising

on operations and dealing with creditors in other countries.

This could be further complicated where property is located in a foreign country providing security for a debt so that domestic assets can be used to pay unsecured creditors. Foreign creditors may have valid claims in domestic bankruptcy cases, and domestic creditors may have valid claims in foreign bankruptcy cases. Any one of these situations can give rise to a transnational insolvency problem.
